## 2. Eligibility

### Standard Admission (including International Students)

Applicants must meet ONE of the following requirements (1) to (8).

If you intend to apply under the conditions (4) to (8), you are highly recommended to consult with the Admission Office before submitting your application form, due to the fact that these articles require the applicants' precise understanding and interpretation.

- (1) Those who hold, or are expected to receive a Master's or professional degree by March 31, 2027 in Japan.
- (2) Those who hold, or are expected to receive a degree equivalent to a Master's or professional degree from schools outside of Japan by March 31, 2027.
- (3) Those who hold, or are expected to receive a degree equivalent to a Master's or professional degree by taking a correspondence program in Japan whereas the program is provided by a foreign school by March 31, 2027.
- (4) Those who hold, or are expected to receive a degree equivalent to a Master's or professional degree by March 31, 2027, through courses prescribed by the Ministry of Education, Culture, Sports, Science and Technology (MEXT) and offered at a foreign educational institution in Japan where the said institution is officially recognized by MEXT as a foreign educational institution that is accredited under the educational system in that country.
- (5) Those who hold, or are expected to receive a degree equivalent to a Master's degree by March 31, 2027, through courses offered by the United Nations University; which was founded under Paragraph 2, Article 1 of the Act on Special Measures Incidental to the Enforcement of the Agreement between the United Nations and Japan regarding the Headquarters of the United Nations University (Act No.72 of 1976).
- (6) Those who meet ALL of the following requirements (a) to (c); (a) who have taken courses of foreign schools, educational institutions authorized under the article (4) above, or the United Nations University; (b) who have passed or are expected to pass the examination and the screening stipulated in Article 16-2 of the Standards for the Establishment of Graduate School (Ministry Ordinance No.28 of 1974) by March 31, 2027; (c) and who are acknowledged by the Graduate School of Informatics and Engineering of the University of Electro-Communications to have an academic ability equivalent to a Master's degree.
- (7) Those who are acknowledged by the Graduate School of Informatics and Engineering of the University of Electro-Communications to have an academic ability equivalent to a Master's or professional degree (under Minister of Education, Culture, Sports, Science and Technology Public Notice No. 118, 1989).
  - \* The specific requirement for this category is as follows.

Those who have experience in engaging in research activities for at least 2 years at a university, research institute, or other institution in Japan or abroad by March 31, 2027, following the graduation from a Japanese university, or completion of 16 years of education in a foreign country or correspondence courses offered by a foreign school, and those who have been acknowledged by the Graduate School of Informatics and Engineering to have an academic ability equivalent to Master's or professional degree, on the basis of research achievement (books, scholarly papers, academic lectures, patents, and work experience, etc.).
- (8) Those who are 24 years or older as of March 31, 2027 and passed the Eligibility Screening administered by the Graduate School of Informatics and Engineering of the University of Electro-Communications.
  - \* This requirement is applicable to those who do not fall under the eligibility conditions (1) to (7) above, and who have been acknowledged by the Graduate School of Informatics and Engineering to have an academic ability equivalent to Master's or professional degree, on the basis of research achievement (books, scholarly papers, academic lectures, patents, and work experience, etc.).

## Special Admission for Mid-Career Students

Applicants must meet ONE of the requirements (1) to (8) above and also must have an experience of full-time working in industry, research institute, or equivalent organizations for 2 years or more by the day of enrollment.

**Those who intend to continue working after enrollment must obtain the consent of their employer.**

### **[Eligibility Screening]** (Standard Admission and Special Admission for Mid-Career Students)

Those who intend to apply for this Doctoral program based on one of the eligibility requirements from (6) to (8) above are subject to screening by the Admission Office prior to the acceptance of their applications. After consulting with Admission Office, please submit the prescribed forms to the Admission Office in person or by postal mail (simplified registered mail 【簡易書留郵便 *Kani-Kakitome yubin*】 ).

**Office hour:** 10:00 to 12:00 and 13:00 to 17:00, except Saturdays, Sundays and holidays.

The required forms will be provided upon prior consultation with the Admissions Office.

Applicants must contact the Admissions Office sufficiently in advance of the application deadlines. The results will be informed by post.

### 3. Application Process

Applicants residing outside Japan must consult with the Admissions Office in advance. Applications sent via overseas postal services will not be accepted without prior consultation with the Admissions Office.

Applicants residing outside Japan should contact their prospective supervisor or the Admissions Office for further instructions on the application procedure.

Applicants must prepare all required application documents listed on pages 5–8 and submit them either in person to the Admissions Office of UEC or by simplified registered mail (簡易書留郵便, Kani-Kakitome Yūbin).

All documents must arrive within the application period.

Incomplete applications will not be accepted.

- (2) Export Control

Under the Foreign Exchange and Foreign Trade Act and applicable acts and ordinances, UEC stipulates The University of Electro-Communications Regulations on Security Export Control to prevent research outcomes to be diverted to the development, production, etc., of the weapons of mass destruction (WMD); and rigorously conducts screening in relation to export of goods and transfer of technology.

Accordingly, with regard to the acceptance of international students, there may be restrictions on academic and research activities you wish to pursue if it is subject to the control under the applicable acts and ordinances. For this reason, international students should fully consult with your prospective supervisor in advance regarding application. In addition, international students are required to sign a designated pledge to comply with applicable export control laws and regulations upon enrollment.

1. You paid the fee but you did not submit the application.
  2. You submitted an application but it was not accepted because of incomplete documents or some other reasons.
  3. You accidentally made a double payment of the fee.

**Note:** The applicants need to bear the bank transfer fee for the process of refunding the exam fee. For details about the procedure for the refund, contact the Payment Section of the Financial and Accounting Office (Tel: 042-443-5040).

- (6) If any invalid or false information is found in the application documents, permission for enrollment may be withdrawn.

## 9. Enrollment Procedures

### Notes:

1. The enrollment fee and the tuition are subject to be revised. If the tuition is revised while you are enrolled, the revised tuition will be charged from the time of the revision.
2. The enrollment fee is not refundable.
3. Japanese Government (*Monbukagakusyo*, MEXT) Scholarship students do not need to pay the enrollment fee and the tuition.

## 10. Handling of Personal Information

Personal information shall be handled in accordance with “Act on the Protection of Personal Information” and “University of Electro-Communications Policy on the Protection of Personal Information”.

- (1) The university shall use applicants’ name, address, or other personal information provided on application documents for the purposes of selecting successful applicants (processing applications, conducting screening); announcement of successful applicants; conducting admission procedures and other related services.
- (2) Information such as examination scores and performance used to screen applicants may be utilized for surveys/research on or analysis of future enrollees’ selection methods, and preparation of materials to consider public relations activities—in a way that will not identify individuals.
- (3) Through processes involved in (1) and (2) above, some tasks may be outsourced by the university to contracted service providers (hereafter referred to as “contractors”).  
If that is the case, all or some of the personal information of applicants possessed by the university may be provided to the “contractors” only within the scope necessary to perform the tasks for which they have been contracted.
- (4) Personal information of admitted students shall be used for the purposes of:
  - ① student affairs (management of school register and academic advising, etc.);
  - ② support to students (health management, tuition waiver and scholarship applications, career support, etc.); and
  - ③ tuition fee collection.
